Scheme of Examination:

The Examination in Sociology offered as a subject for the General Degree Examination in Arts (External) shall consist of three papers of three hours each, as follows:

SOCIOLOGY	I (SSG 1)	Theories and Methods in Sociology
SOCIOLOGY	II (SSG 2)	Applied Sociology
SOCIOLOGY	III (SSG 3)	Sociology of South Asia

SOCIOLOGY I (SSG 1) : Theories and Methods in Sociology.

This paper consists of two parts. Part one deals with classical and modern theories in Sociology. Part two assesses the candidates' knowledge in relation to the problem of scientific enquiry and techniques of sociological research.

1. The historical and sociological background of the development of sociology. The main stages in the development of sociology.

2. Classical Sociological Thought

a. Evolutionary and organic models of society.

b. The contributions by Marx, Durkheim and Weber.

3. Modern Sociological Theories

a. Functionalism

b. Conflict Theories

c. Social Interactionism

Part Two : Research Methods

1. The scientific method and the nature of social sciences.
2. Types of sociological investigation; historical research vs field research, exploratory vs hypothesis-testing studies.
3. Types of research designs; Field Studies and Surveys.
4. Research process, problem identification, definition of concepts and operationalisation of research design.
5. Data collection methods, use of records, observation, questionnaires and interviews.
6. Processing and analysis of data; problems of measurement, basic statistical calculations with special reference to measures of central tendency and dispersion.

SOCIOLOGY III (SSG 3) : Sociology of South Asia

This paper deals with the social organization and culture of South Asia with special reference to India and Sri Lanka. The following topics are included:

1. Historical, geographical and cultural background of South Asia.
2. The concept of peasant society and culture as applied to South Asia: the contributions by Robert Redfield, Eric Wolf, G.M.Foster McKim Marriott, D.G.Mandelbaum and Gananath Obeysekere.
3. Sociology of Hinduism and Buddhism, with a focus on religious revival and change during the 20th century.
4. Caste in India and Sri Lanka: nations of purity and pollution; jajmani system; sanskritization; the role caste in modern society.
5. Kinship and marriage; Dravidian Kinship terminology; Hindu joint family; Deega and Binna forms of marriage in Kandyan Society; dowry system; cross-cousin marriage; the changing aspects of kinship and marriage.
6. The Ayurvedic system of medicine; its conceptual basis and revival in modern times.
7. Continuity and change in South Asia.
